**ORDER**

**Subject:** Prohibition of Unauthorized Stacking and Disposal of Construction Materials, Debris and Garbage on Roads and Public Places.

In pursuance of the provisions of the Solid Waste Management Rules, 2026 and in the interest of public health, sanitation, environmental protection, and free movement of traffic and pedestrians, it is hereby ordered that no person/ contractor / builder / house owner / institution / agency shall:

- Stack or dump sand, bricks, stone chips, earth, cement, iron rods, construction and demolition waste, or any other construction materials on Public roads, Footpaths, Drains, Road margins, Open public spaces, or Any Government land/public place, without prior written permission from the competent authority.
- Dispose of household garbage, construction debris, demolition waste, plastic waste, or any solid waste outside the campus/premises or at unauthorized locations.
- Cause obstruction to traffic movement, drainage systems, pedestrians, or public convenience

All residents, builders, contractors, commercial establishments, and institutions are hereby directed to:

- Store construction materials strictly within their own premises/campus.
- Ensure scientific collection and disposal of waste through authorized agencies/designated dumping sites only.
- Maintain cleanliness in accordance with applicable municipal laws and the Solid Waste Management Rules, 2026.

Any violation of this order shall attract:

- Cancellation of Building Permission, denial of Occupancy Certificate, Trade License etc.
- Imposition of fines/penalties as per applicable Municipal Laws and SWM Rules.
- Recovery of cleaning/removal charges from the violator.
- Seizure/removal of materials by the authority concerned.
- Initiation of legal action as deemed fit.

Concerned officials/ enforcement teams of Dibrugarh Municipal Corporation are directed to conduct regular inspections and take immediate action against violators. This order shall come into force with immediate effect and shall remain applicable until further orders.
